Pupil Premium – Are you entitled? If you find that your circumstances have changed recently due to the COVID pandemic you may be entitled to Pupil Premium. If you are, then you could get help towards payments for trips and Free School Meals for your child. It's easy to do. All you need to do is call the South Area Education Office on 01772 532109 or click on the link

It must be the person claiming the benefit that rings. You will need to provide your name, date of birth and National Insurance Number. They will confirm whether you are entitled over the telephone. Alternatively complete the form and hand into the school office. Pupil Premium is completely confidential and other pupils and families will not know if you gain access to the funding.

Benefit Based Free School Meals: Whilst we are on lockdown, the Edenred Voucher Scheme will be available again to all families who are in receipt of benefit based Free School Meals. We will be in touch once the new guidance has been received.

Mobile Data Allowances: The Department for Education has introduced a pilot offer to increase mobile data allowances for children and young people. This scheme is open to children and young people who don't have access to a fixed broadband connection, cannot afford the additional data needed to access educational resources or social care services, have access to a mobile device that uses a participating network, are facing disruption to their face-to-face education or have been advised not to attend school. The participating providers are EE, Sky Mobile, Smartly, Tesco Mobile, Three & Virgin Mobile. If you think you meet the above criteria and would like school to request extra mobile data, we will need to collect the following information: the account holder's name, their mobile number (a number beginning with '07'), their mobile network, whether they pay monthly or pay as they go, account holders with monthly contracts need to be over the age of 18. Please follow this link which explains the DfE privacy policy to the account holder. For more information please refer to the email that was sent out today and if you are interested please return the form to school by 9am on Tuesday 12th January.

National Online Safety: Remote education ensures continuous learning outside the classroom. For parents and carers, remote education isn't always straightforward and there can be a number of factors they need to consider, especially around ensuring their children feel comfortable and are familiar with the whole concept. National Online Safety have created a guide to help parents and carers support their child in getting the most out of their remote education experience.

In the guide, you'll find tips on a number of potential issues such as creating a safe learning environment, adhering to school policies and making sure the appropriate systems and communication channels are in place so that educators, parents and carers get the most out of their remote education experience.
